## SHIPPING INFO

Customers need to print and fill out this order form and include it with your firearm when shipped. Each customer must include a photocopy of their driver's license, photo ID, or FFL (if applicable). Please include a copy of Battle Ready Arms, FLL in package, as well. If applicable, please provide a copy of military or LE credentials for 5% off purchase. Please unload and ship the whole firearm or frame (does not have to be stripped) to:

Federal law requires that the carrier be notified that the shipment contains a firearm. Do not mark anywhere on the outside of the package to indicate there is a firearm inside. All firearms must be shipped overnight via UPS or FEDEX with adult signature. This rule does not apply to P320 modules or other nonserialized parts. Only FFL holders may ship handguns via USPS. Customers are responsible for return shipping, as well. Return shipping charges will be added to your final invoice once work is completed. Payment is due upon completion of work. Your firearm will be returned using overnight shipping with insurance and adult signature. If your return address is different from your state issued photo ID your firearm will have to be shipped to a local FFL. If payment is not received within 60 days of completing the project legal action will be taken to take possession of the firearm inorder recoup the price of work.
